

1. Background

WA Health Networks enable everyone with an interest in health to connect with others, share their expertise and experience to improve the health system and the health of all Western Australians. WA Health Networks are unique in that they bring together diverse partners across health to identify a shared vision for health reform and to improve service quality and care.

In April 2015, the WA Health Networks commenced the development of the WA Health Networks Strategic Direction 2015-2020. The aim of the Strategic Direction is to ensure the WA Health Networks continue to play an important role in identifying opportunities to create a culture of collaboration and to influence positive change to the health system.

In May 2015, consultation with WA Health Networks' stakeholders commenced to gather data to inform the priorities and guiding principles for the Strategic Direction.

The consultation was undertaken in three stages:

- Stage One: Face to face interviews with key strategic stakeholders across the WA health system.
- Stage Two: Online consultation via a Citizen Space survey with stakeholders registered on the WA Health Networks database. The purpose of the consultation was to collect feedback on the priorities and guiding principles of the Strategic Direction. The results were collated in a report which is available on the WA Health Networks website www.health.wa.gov.au (under Improving WA Health).
- Stage Three: Second online consultation via a Citizen Space survey with stakeholders registered on the WA Health Networks database. The purpose of the consultation was to collect feedback on the overall vision and proposed activities of the Strategic Direction.

Between stages two and three, the draft Strategic Direction was edited to incorporate the feedback gathered from the initial online consultation.

This report details the findings from stage three of the consultation.

2. Aim and Objective

Feedback from the survey was used to draft the Strategic Direction and provide input into an operational plan for the WA Health Networks.

A specific objective of the survey was to measure support across the four key action areas:

- engagement
- pathways
- planning
- leadership.

3. Methodology

3.1 Survey

Stakeholder input for the WA Health Networks Strategic Direction 2015-2020 was collected using a self-completion questionnaire. A copy of the questionnaire is provided in Appendix 1.

The questionnaire included five open-ended questions.

Citizen Space, an online consultation tool, was used to design and collect survey responses. A hard-copy of the survey was available on request.

3.2 Sampling

The sampling frame included all persons and/or organisations listed on the WA Health Networks members' database that includes clinicians, consumers and carers, policy makers, planners and researchers across the public and private health sectors.

3.3 Data collection

Respondents were invited to participate via an email invitation (see Attachment 2), which included a link to the online survey tool. The survey was open for two weeks from 30 June to 14 July 2015.

3.4 Data analysis

Quantitative data from the self-completion questionnaires was downloaded from Citizen Space and analysed using Microsoft Excel. Qualitative data was analysed using thematic analysis; this was used to identify recurring themes that represented common views of the respondents.

4. Results

4.1 Responses

In total 45 survey responses were received, including 11 received from organisations (24 per cent of responses).

4.2 Demographics

Respondents to the survey were asked to provide basic demographic information about their:

- primary role in the health sector (Figure 1)




Figure 2: Respondents' primary place of work

- primary place of work (Figure 2)





Figure 3: Respondents' involvement in Health Networks

- involvement with Health Networks (Figure 3).

The following response patterns are noted in the demographic responses:

- 76 per cent of responses were received from individuals and 24 percent were received from organisations.
- 51 per cent of respondents worked in the WA Health Services (either the South Metropolitan, North Metropolitan, WA Country or Child and Adolescent Health Service).
- 67 per cent of respondents were employed by the WA Department of Health.
- 36 per cent of respondents reported that their primary work role involved the provision of health services (nurse/midwife, allied health practitioner or medical officer).
- 7 per cent of respondents reported their primary role as either a consumer, carer or health advocate.
- 84 per cent of respondents were involved with one or more of the WA Health Networks.
- 7 per cent of respondents identified as Aboriginal or Torres Strait Islander.

Figure 1: Respondents' role in the health sector

4.3 Respondents' satisfaction levels regarding the Strategic Direction




Figure 4: Satisfaction ratings for extent to which the Strategic Direction identifies a way forward for WA Health Networks in the next five years

Survey respondents were asked to rate their level of satisfaction with which the Strategic Direction identified a way forward for WA Health Networks in the next five years. The satisfaction results are presented in Figure 4.

Respondents were also asked to provide comments on the proposed way forward for WA Health Networks. Feedback was received from 51 per cent of respondents and common themes included:

- the importance of engagement with a broad spectrum of partners
- a desire for greater clarity in how the action areas of the Strategic Direction will be operationalised
- the importance of patient-centred policy development which effectively engages all individuals and organisations across the health care sector.

"Representation of external partners should be enhanced/broadened."

"The Networks offer an opportunity to synergise with and optimise the performance of health services to deliver appropriate services to optimise patient health outcomes."

"The Strategy aligns well with other international and contemporary health reform, the importance of service integration and focus on "place" of care (e.g. community) is crucial. Principles of equity and accessibility are key influencers, but even more key are tangible local supports...a networked, connected pan state approach to community service design and delivery will be beneficial to outcomes."

4.4 Respondents' support for the four key action areas




Figure 5: Support rating for the four key action areas outlined in the Strategic Direction

Survey respondents were asked to rate their level of support for the four key action areas outlined in the Strategic Direction. A brief description was provided (embedded in the survey) for each of the four key action areas. The support rating results are presented in Figure 5.

Respondents were also asked to provide comments on the key action areas. Feedback was received from 31 per cent of respondents and included:

- strong support for the four key action areas
- the importance of engagement with specific populations or professions, e.g. Aboriginal people and allied health workers
- the need to engage with Area Health Services, specifically in the pathways and planning action areas
- the importance of adequate resource allocation required, specifically staffing within Health Networks, to progress the four key action areas

"Completely agree with focus on engagement, pathways, planning and the cultivation of leadership. I also completely agree with the increased focus on developing partnerships with the primary health networks, the Mental Health Commission and Disability Services Commission."

"(Our organisation) highly supports the pathways aspect of the four key action areas. The Aboriginal Health sector must be involved in the development of this area at a local level."

"The Networks progress many fantastic initiatives with the limited staff at their disposal and I feel that more development/policy/project officers are required to continue the great work."

4.5 Respondents' suggestions as to how to improve the Strategic Direction

Survey respondents were asked to identify what (if anything) they believed was missing and/or could be improved in the Strategic Direction.

Survey responses were analysed and categorised by theme; responses were received from 64 per cent of respondents. The two most common themes evident in the feedback were:

- queries on the operationalisation of the Strategic Direction, including resourcing, accountability and implementation
- the importance of engagement of consumers, carers, areas health services and other government agencies.

"Harnessing health outcome data to drive decisions regarding health service modelling, development and implementation [is missing from the Strategic Direction document]."

"Quality and accountability markers in terms of ensuring this document influences change, design, implementation, sustainability and outcomes. Having identified markers for progress and person accountable for that progress will ensure the tangible impacts continue to be driven."

"Reinforcing the role of informed health consumers interacting with (our) responsive health system provides a powerful paradigm for influencing the development of health services and models of care provides an opportunity for innovation."

4.6 Respondents' role in helping achieve the Strategic Direction

Survey respondents were asked what role they believed they, as individuals or organisations, could play in helping WA Health Networks achieve their Strategic Direction.

Survey responses were analysed and categorised by theme; responses were received from 71 per cent of survey respondents. The range of responses were thematically analysed and categorised into one of the four key action areas.


- engagement
- leadership
- pathways
- planning.

Of those survey participants who responded, 50 percent identified their capacity for influence spanning across two or more key action areas.

Feedback demonstrated the broad range of skills, knowledge and professional networks that respondents could contribute towards helping achieve the strategic direction.

More than 20 percent of respondents nominated an interest in helping Health Networks engage with rural and remote health services.

4.7 Other feedback

Survey respondents were asked to provide further comments relating to the future direction of WA Health Networks. Just under half of the total survey respondents provided feedback to this question.

The feedback received was broad-ranging. The two most common themes identified from the responses were:

- accountability; how Health Networks can increase accountability by:
 - demonstrating evidence of their effectiveness, thus maintaining their value to the health system
 - o developing KPIs and critical measures as part of an operational plan.
 - engagement; how Health Networks can increase stakeholder engagement by:
 - o utilising ICT available through the Department of Health
 - o enhancing communication with Network members to increase participation.

"I believe that as we are rapidly moving into a health service environment that has greater scrutiny around efficiency. ... I feel that the strategic direction document captures the essence of this and communicates a clear plan to measure effectiveness through KPIs and in doing so will assist the Networks to remain accountable and sustainable for the future."

"The networks should focus on engagement across all sectors and health sites and the community."

5. Next Step: Developing an Operational Plan for WA Health Networks

The responses to this consultation were used to further refine the final Strategic Direction for WA Health Networks.

The final document was then presented to members of the WA Health Networks Leads' Forum for endorsement. Following this, the WA Health Networks Strategic Direction 2015-2020 was then formally endorsed by the Assistant Director General, System Policy and Planning, Department of Health.

The Strategic Direction has now been made publicly available on the WA Health Networks' website <u>www.health.wa.gov.au</u> (under Improving WA Health) and a Communications Plan has been developed to drive awareness of, and engagement with the Strategic Direction.

An Operational Plan is currently being developed by the WA Health Networks to achieve the vision and key action areas outlined in the Strategic Direction. It takes into account all the feedback received across the three stages of consultation.


